UAA 2019 Annual General Meeting



Other sessions featured Peter McPherson, former USAID Administrator, Derek Gianino of the U.S. Global Leadership Coalition, and USAID Deputy Administrator, Bonnie Glick. The meeting also included the announcement of new UAA Board members, UAA Alumni of the Year awards for Mary Lewellen and Lawrence Heilman and a special posthumous recognition of lifetime achievement awards for Peter Kimm and John Sanbrailo. UAA Book Club

On October 23, twelve members of the UAA Book Club met at the BISTRO 1521 Restaurant in Arlington, VA, for a discussion, led by Jim Fox, of **Cass R. Sunstein**, *How Change Happens*, 2019. Jim's summary outline of this book is posted in the UAA Book Club Reviews section of the UAA website. This is a complex and difficult book, dealing with a wide range of ideas and thoughts about how we think and why we think the way we do. However, this book is not a how-to guide for producing cascades of social change. It is rather a multifaceted investigation into how people collectively develop views on important social and legal matters.

Public Outreach

The UAA continues its interest and activities to reach out to imminently departing and former **Foreign Service Nationals** both here and overseas to strengthen their joining the association. A UAA Public Outreach Committee Member and a recently elected Board member, Jim Bever, was invited to join USAID HQ's conference call on October 31st with its HCTM Foreign Service National (FSN) Unit and with the worldwide elected Members of the FSN Advocacy Council. They discussed ways to inform soon-to-leave FSNs and former FSNs that are eligible to join UAA, and to invite Mission FSN Committees to establish pilot in-country Retired FSN Chapters of UAA. The FSN Advocacy Council agreed to explore these initiatives further, together with FSN Committees, HCTM FSN Unit in Washington, and UAA.

Committee Co-Chairs Beth Hogan and Jim Bever also had a productive discussion with the policy and advocacy officers of the U.S. Global Leadership Coalition to explore opportunities for UAA engagement with USGLC in the coming year for public education and advocacy supportive of U.S. foreign development assistance in the American people's interest.

American University Archives as Home for USAID Alumni Memorabilia

American University Archives offer an opportunity for USAID alumni to find a home for personal memorabilia of their USAID service. We have often been asked by UAA retirees what could be done with these materials currently stored in boxes in their basements. We now have an answer!

The American University Library has a very impressive archival program. Several years ago the AU Library Archives created a Peace Corps Community Archive in which the Library collects, preserves, and makes available materials that were created and acquired by Peace Corps Volunteers. In collaboration with the USAID Alumni Association, the AU Archives are now offering a similar program for USAID alumni. This program is not intended to collect official USAID documents which are best donated to USAID's Development Experience Clearinghouse (DEC). Rather, as is spelled out in detail in the information posted on the UAA website, American University is looking for "personal materials created and acquired by USAID alumni during their assignments, such as correspondence, diaries, film, photographs, memoranda, reports, scrapbooks, newspaper articles, host country documentation, presidential or other VIP visit schedules and documentation, and sound recordings ..." and much more.

Former USAID Officers Sign Letter of Support for Department of State Colleagues

USAID retirees continue to mobilize support, including funds for legal defense, for Department of State colleagues now under siege from the Trump administration. More than 400 retirees, including Ambassadors, Mission Directors and senior technical specialists, representing decades of experience around the world, have signed a letter criticizing the Trump Administration both for the conduct of foreign policy and for the treatment of highly professional Foreign Service Officers like Ambassadors Bill Taylor and Marie Yovanovitch. The letter is still open. If you would like to sign, please send a note with your name and last title at USAID to desaixmyers@gmail.com.

If you would like to do more, you may want to contribute to the American Foreign Service Association's Legal Defense Fund for FSOs being called to testify and facing rapidly mounting legal costs. A link to the letter, list of signers and the AFSA Legal Defense Fund can be found by [clicking here](#). AFSA is now estimating that the costs could amount to \$25,000-\$35,000 per officer. So far, they have raised enough for two or three officers from 818 contributors since their solicitation in early October. Thirty-eight USAID retirees have donated.

Alumni Profiles

Mary L. Lewellen, UAA Alumna of the Year 2019



Mary Lewellen, a retired Foreign Service Office (1977-2003), has repeatedly demonstrated a keen interest and competence in all aspects of international development and foreign policy. Neither retirement, cancer surgery followed by chemotherapy nor a detached retina have slowed down her active involvement. Mary has continued to serve by teaching and mentoring college students; organizing and leading service and learning trips to rural South Africa, Nepal, Ethiopia, and Thailand; and training USAID staff around the world.

For her many years of outstanding and continuous service to U.S. students and overseas schools and communities, Mary Lewellen was selected as the UAA 2019 Alumna of the Year for both international and domestic service. Here are some examples of the path of service Mary has taken in retirement.

For the past fourteen years, she has taught college classes at Sierra Nevada College. She is the Chairperson of International Studies and International Business. From Mary's inspirational lessons learned from serving abroad with USAID, the students voted her "Outstanding Faculty Member" in 2015.

For the last seven years, Mary has done the year-long planning with African partners to organize and lead 25-30 American college students to do service and learning for three weeks in the rural areas of South Africa. Students cover their own expenses, but Mary invariably donates funds or frequent flyer miles to enable under-privileged students to make the trips. They have helped expand and renovate schools, an HIV clinic, and school and community vegetable gardens. Mary and husband Ted personally provide funds for hundreds of children's books, suitcases full of schools supplies, renovation supplies, and to rebuild sports facilities.

Mary has also structured college classes in South Africa for academic credit for the American students along with their daily work and service schedule. The American students return to the United States openly stating, "This is a life-changing experience."

Moreover, Mary has continued to serve in USAID and train and mentor USAID staff around the world. She has been contracted to serve in senior positions in USAID Missions and trains around the world in USAID programming, project design, acquisition and assistance. In 2019, Mary completed her 17th training assignment in Afghanistan.

Throughout nearly 30 years of retirement, Larry Heilman has brought the same qualities of unrelenting energy, passion, and intellectual curiosity to his community that were manifest during his 28 years working in international development. The impressive results include strengthening Rotary International programs around the world; improving local government capacity in his community; boosting Latin American studies at universities; and working with the Wounded Warriors program at Walter Reed Hospital.

A member of Rotary International for 29 years, Larry has supported the expansion of its economic, humanitarian, and disaster assistance activities in education, health, and environment in more than 15 developing countries with over 40 projects ranging in value from \$700 in India to \$20,000 in Guatemala. He has also supported 60 Rotary

Larry served as elected Treasurer of the Board of Managers for his community. While on the Board, he promoted the creation and initially chaired public safety, environment, and elections committees with an eye to promoting greater citizen participation in local government.

Since retiring, Larry has taught Latin American history courses at Montgomery College, Johns Hopkins, and University College, University of Maryland. For 17 years, he has taught *pro bono* a course at the Osher Lifelong Learning Institute on "The Evolution of Civilization in Meso-America." Larry continues as a research associate in anthropology at the Smithsonian's Natural History Museum. Recently, his study, *USAID in Bolivia, Partner or Patron*, was published.

Diagnosed with melanoma and treated at Walter Reed Medical Center, Larry joined the hospital's active Wounded Warriors chapter. At 78, Larry became a member of the kayak team organized to give soldiers who lost their legs in combat a chance to regain a sense of control. He helped the group raise funds to support a suicide detection program. He continues to plough the waters of the Potomac with his buddies.



Larry Heilman was awarded UAA Alumnus of the Year for 2019 based on his remarkable second career of service in retirement. The results produced continue to enrich many lives at home and abroad.
