Wednesday, June 16, 2021, 2:00-3:30 p.m. – At the UAA Development Issues Committee next meeting, the topic for discussion will be "U.S. Assistance is More Valuable than One Belt, One Road: A Conversation about Competition with China." The guest discussion leaders will be former USAID Deputy Administrator Bonnie Glick, now Senior Advisor to the CSIS Project on Prosperity and Development and Justin Finnegan, former USAID Deputy Assistant Administrator (DAA) for Food Security, now with Bloomberg Media. **Wednesday, June 23, 2021, 1:30-3:30 p.m.** -- The **UAA Book Club** will hold a virtual meeting via Zoom for which **Joe Ryan** will lead a review of *The Authoritarians,* 2006, by Bob Altemeyer. The meeting is open to all UAA members who have made a UAA contribution in 2021. A registration link for the Zoom session will be circulated later.

Wednesday, July 7, 2021, 12:00-1:00 p.m. -- The UAA/DACOR Development Dialogue will feature Greg Starr, lead author of a recent American Academy of Diplomacy report, *Changing the Risk Paradigm For US Diplomats* at a virtual meeting. Starr is former U.S. Assistant Secretary of State for Diplomatic Security and UN Under-Secretary-General for Safety and Security. Brief comments will be provided by two UAA board members and former mission directors, **Jim Bever** and **Chris Crowley**. Effective diplomacy and development to meet national interests requires a method to engage more broadly even in high-threat locations. Starr will highlight several suggested changes to address the growing level of risk intolerance experienced in U.S. missions abroad.

**Saturday, September, 2021, date/time/location TBD --** The UAA annual **Summer Picnic** will be held in the D.C. area or virtually via Zoom, depending on the coronavirus pandemic situation nearer the planned date. A hybrid picnic, held both in person and virtually, is also being considered. Stay tuned.

**Friday, October 29, 2021, time TBD --** The **UAA Annual General Meeting** will be held at the Center for Global Development in Washington D.C., if conditions permit. We hope to have the opportunity to hear from Administrator Samantha Power. We have also planned a special panel session on "Development Cooperation: Response to COVID-19 and Efforts to Advance Health Security"; a session (and book-signing opportunity) with John Norris on his new book about the history of USAID; and a session on how UAA Alumni can engage in more organized community outreach on development issues. #### **UAA Development Issues**

On May 19, 2021, the UAA Development Issues Committee sponsored a highly informative discussion on the "Challenges of Transforming Education in Developing Countries through the Pandemic and Beyond." The discussion leaders were former USAID Mission Director Charles North, now Deputy Chief Executive Officer of the Global Partnership for Education (GPE), and Susannah Hares, Co-Director of Educational Policy and Senior Policy Fellow at the Center for Global Development (CGD). Susannah **Hares** led off the discussion with a slide presentation of a recent CGD analysis of the impacts of the pandemic on education. **Charles North** reminded us that there was a crisis in education even before the pandemic, particularly for girls who may be forced into child marriages or into working at household chores, preventing them from attending school. The Global Partnership for Education provides grants to educational partners working at the country level to increase the capacity of educational systems, identifying and implementing transformational solutions to improve education and accelerate girl's education. The initial presentations were followed by a robust Q & A session which addressed a wide range of issues. A more detailed summary of the discussion can be found by clicking **here**.

#### Alumni Profile: Stacy Rhodes



Stacy Rhodes came to USAID in 1978 from the State Department's Legal Office, after a trip to Bolivia -and a return visit to his former Peace Corps site in the Andes -- resulted in the epiphany that he was working for the wrong USG agency. He was assigned to Haiti, but wisely first asked his long-time girlfriend, Trish, to marry him. Luckily, Trish was willing to leave her career as a Washington firm's law librarian and move to Port-au-Prince and start a family! Four years later, with two beautiful little daughters, Amanda and Maggie, they were off to Morocco, and then Nepal, where he became Deputy Director and son Max was born.

Following a year of study at Duke University, Stacy served as LAC Director for Central America, before

being named Mission Director for Guatemala and Central American Programs where he worked on critical human rights issues, strengthening the justice system, and implementing the Guatemalan Peace Accords. In 1998, Stacy became Mission Director in Nelson Mandela's South Africa, where USAID supported the historic transformation from 'apartheid' to democracy. Stacy completed his USAID career in 2001. While serving in these five countries, Trish maintained her career as an educator and raised their three children.

Stacy's "Life After USAID" was busy in the international development community. He worked for NGOs (IIE and Save the Children in Washington), served as Latin America Managing Director at Millennium Challenge Corporation and, to close the circle, "bookended" his career as Chief of Staff of the Peace Corps. Stacy was part of the UAA's founding group, with the encouragement of then Administrator Henrietta Holsman Fore. After assisting in getting the UAA organized, 'legalized,' and initiating programs, Stacy has continued to be an active member, watching the UAA grow and help strengthen the Agency over the past ten years. Stacy has also served on several NGO boards in recent years, and is closely associated with Global Communities.

While it has been twenty years since formally retiring from USAID, Stacy feels like he never really left. He notes that most of his and Trish's closest friends today were colleagues or friends they first met in one of their USAID postings overseas. "In many ways, the most satisfying part of a foreign service career with USAID is the personal part, the bonds you create with people you meet as colleagues, partners or host country counterparts. These links are amazingly strong and durable, formed quickly yet intensely through a shared commitment to doing something together to address poverty and social exclusion."

Stacy and Trish today have retired to their 'shore home' in Chincoteague, Virginia, while maintaining a condo in Arlington. They recommend the slower lifestyle in a smaller town, dedicated more to kids, grandkids and friends. Having survived the pandemic and covid vaccinations, they welcome visits to Chincoteague by UAA colleagues for beach walks, bike rides, or just watching the 'wild ponies' that share the Island!"
